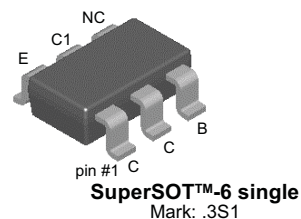

- This device is designed for general purpose high voltage amplifiers and gas discharge display drivers.

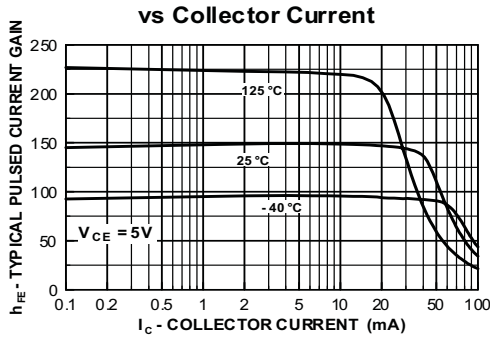


Figure 1. Typical Pulsed Current Gain vs Collector Current

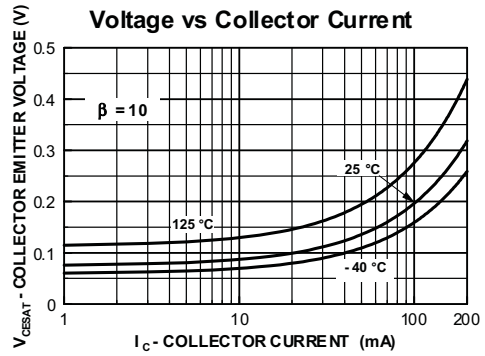


Figure 2. Collector-Emitter Saturation Voltage vs Collector Current

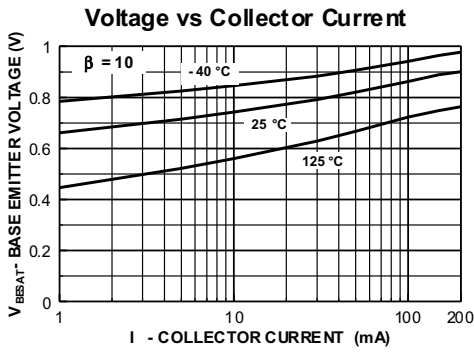


Figure 3. Base-Emitter Saturation Voltage vs Collector Current

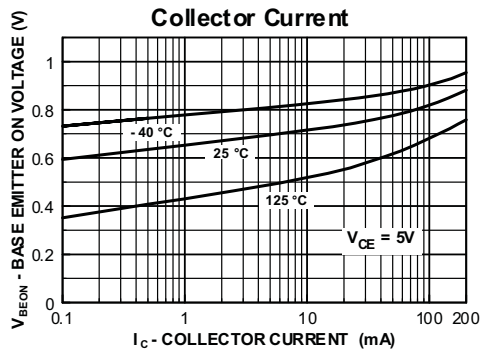


Figure 4. Base-Emitter On Voltage vs Collector Current

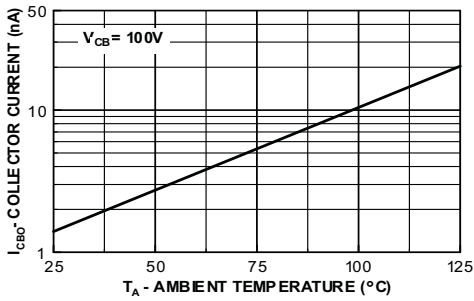


Figure 5. Collector Cutoff Current vs Ambient Temperature

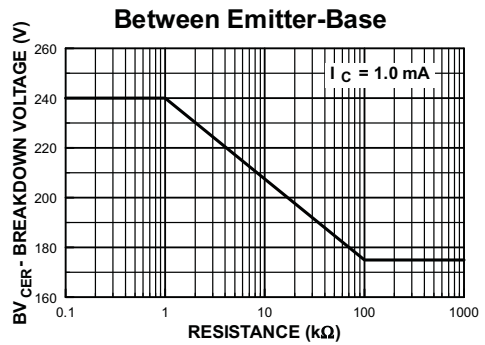
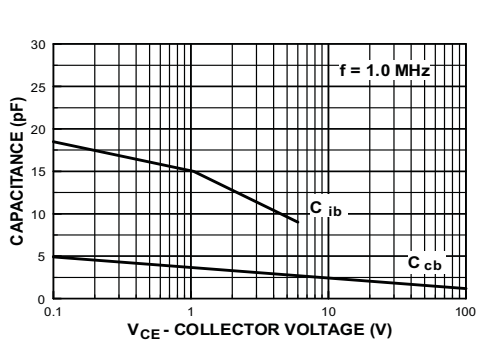
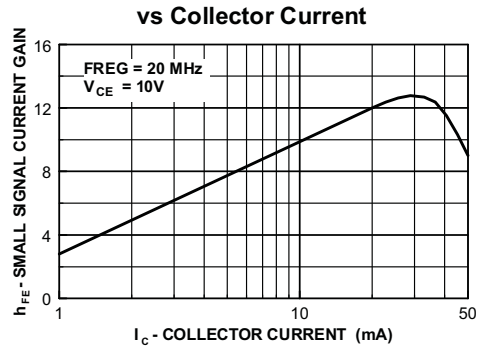


Figure 6. Collector-Emitter Breakdown Voltage with Resistance Between Emitter-Base

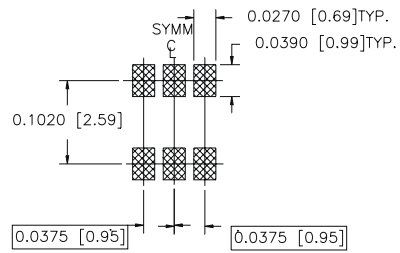
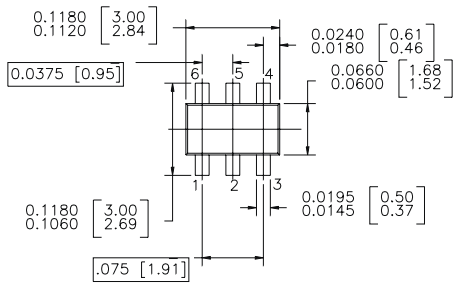
**Figure 7. Input and Output Capacitance vs Reverse Voltage**



**Figure 8. Small Signal current Gain vs Collector Current**

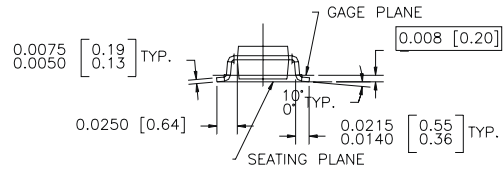
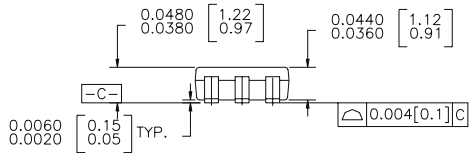
